These new neighborhoods will feature connectivity to the community's many greenspaces, parks and boardwalks including BeachWalk – a paved multi-use trail running parallel to the St. Joseph Bay coastline. Site development began in 2018 and home construction is expected to begin in 2019 with homes being available for sale in early 2020 starting in the \$300,000's.
