



## First-Ever Nonstop Flight to Panama City, Florida Provides Convenient Access to The St. Joe Company's Properties for Travelers From New York City

"Connectivity between Northwest Florida and a major population center like New York City is a crucial element to expanding convenient access to this region to a greater national audience," said Jorge Gonzalez, St. Joe President, Chief

Executive Officer and Chairman of the Board. "We are optimistic that this direct flight will open the door for more travelers from the Northeast, which creates the opportunity for more people to stay at our properties and discover the exceptional quality of life our region has to offer. History has shown us that many vacationers become full-time residents in our residential communities."

This announcement comes on the heels of ECP's best year in 2024 where the airport saw more than 1.8 million passengers, a 13 percent increase as compared to 2023. "This is a historic moment for ECP as we introduce our first-ever nonstop flight to New York City," said ECP Executive Director Parker McClellan. "Partnering with Delta Air Lines to offer this new seasonal service will provide our passengers with more convenient travel options and enhance connectivity between New York City and the beautiful beaches of Northwest Florida."

With flights available for booking now, the new service will begin on June 14, 2025, and will operate once weekly on Saturdays. Additionally, Delta will offer daily service from June 28, 2025, to July 6, 2025, to accommodate travelers for the Fourth of July holiday. The flights will run through Labor Day and will be operated on Delta's CRJ-900 aircraft.
